### OFFICE MEMORANDUM

**Subject: Closure / shifting of field units under ADG (Border).**

Keeping in view the exigencies of work and recommendations made by ADG(Border) vide letter no. ADG(B)/1 (Re-structuring)/2021/443-H dated 16.07.2021, the competent authority is pleased to decide the following:

#### IBBZ-I


1. One post each of SE(Civil) of BFC-III, Murshidabad and SE(Electrical) of BFEC, Siliguri is closed. With this closure, the distribution of work in IBBZ-1 will be as under:
  - (i) SE, BFC-I at Siliguri will have jurisdiction of North Bengal Frontier, upto river Tista.
  - (ii) SE, BFC-II at Krishnanagar will have jurisdiction of South Bengal Frontier.
2. (i) After closure of SE, BFC-III, 1 post of SE(C), 1 post of EE(P)(C) and 1 post of AE(P)(C) are taken in reserve pool of Border Region.
  - (ii) After closure of SE, BFEC, Siliguri, 1 post of SE(E) & 1 post of EE(P)(E) are taken in reserve pool of Border Region.
3. EE, BFD-III (Bunaidpur) unit, EE, BFD-V (Krishnanagar) unit and EE, BFD-IX (Malda) unit are closed. Due to closure of these divisions, 3 posts of EE(C) and 9 posts of AE(C) are taken in reserve pool of Border Region.
4. EE(Electrical), BFED-III, Malda unit is closed. One post of EE(E) is taken in reserve pool of Border Region. One subdivision under EE(E), BFED-III, Malda is attached with BFED-I and second subdivision under EE(E), BFED-III, Malda is attached with BFED-II.
5. Jurisdiction of IBBZ-I will now be extended upto BP 794/3-S from presently BP-764/2-S so that border upto Tista river is looked after by BFD-I, IBBZ-I. Due to transfer of above stretch to IBBZ-I, one subdivision headed by

AE(C) under BFD-IV, Cooch Behar, IBBZ-II, located at Jalpaiguri is closed. The post of AE(C) is taken in reserve pool of Border Region.

### IBBZ-II

6. One subdivision at Dharamanagar, Tripura under BFD-I, Silcharis attached with BFD-II, Agartala. With this BFD-II & BFD III will now have 3 subdivisions each.
7. BFED-VII, Guwahati under BFC-II, IBBZ-II is shifted to Silchar under SE, BFC-I, IBBZ-II, Silchar. BFED VII at Silchar will have 2 subdivisions, one at Silchar and second at Agartala.
8. Jurisdiction of BFED-VI under BFC-II, Silliguri will correspond to this circle's jurisdiction. BFED-VI will have one post of AE(E) at Silliguri and second at Guwahati. One post of AE(E) at Silliguri under BFED-VI is shifted to Agartala under BFED-VII.
9. The post of AE(C)(P) under BFED-VII is shifted to EE, BFD-V as AE(C)(P), Tura.
10. After closure of above units, the following posts will be taken in reserve pool of Border Region:
  - i. SE(C) - 1
  - ii. SE(E) - 1
  - iii. EE(C) - 4
  - iv. EE(E) - 2
  - v. AE(C) - 11
8. Necessary transfer and posting orders will be issued by competent authority separately.
9. Database will be modified by DDG(e-gov& BD) accordingly.
